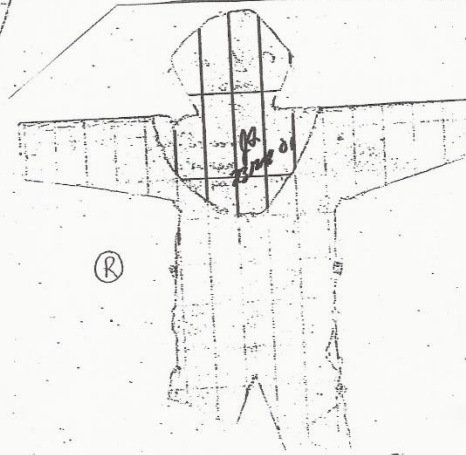

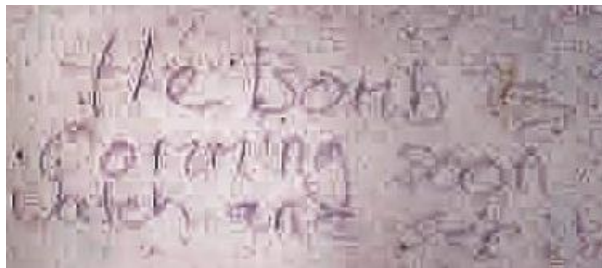

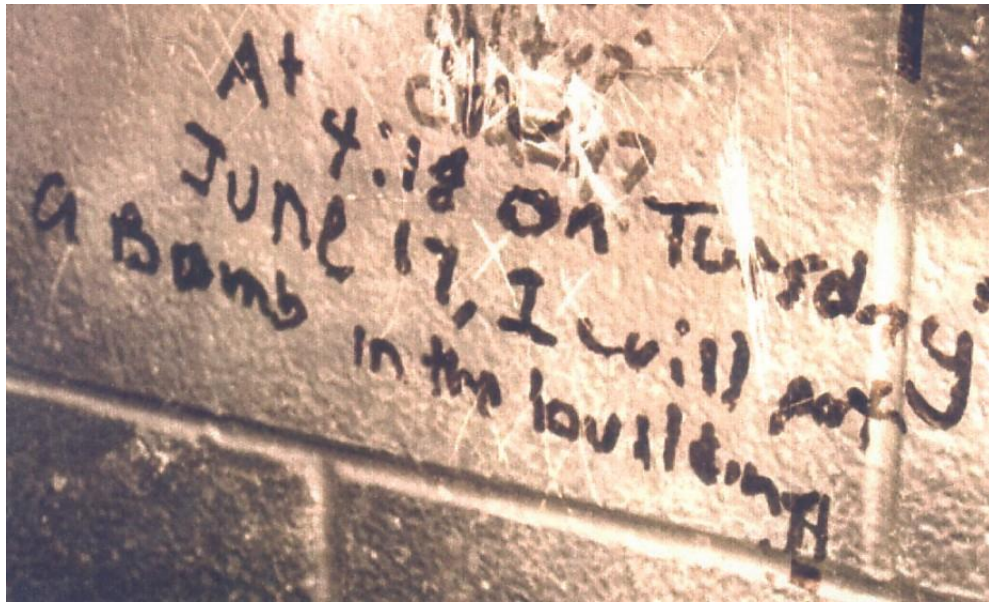

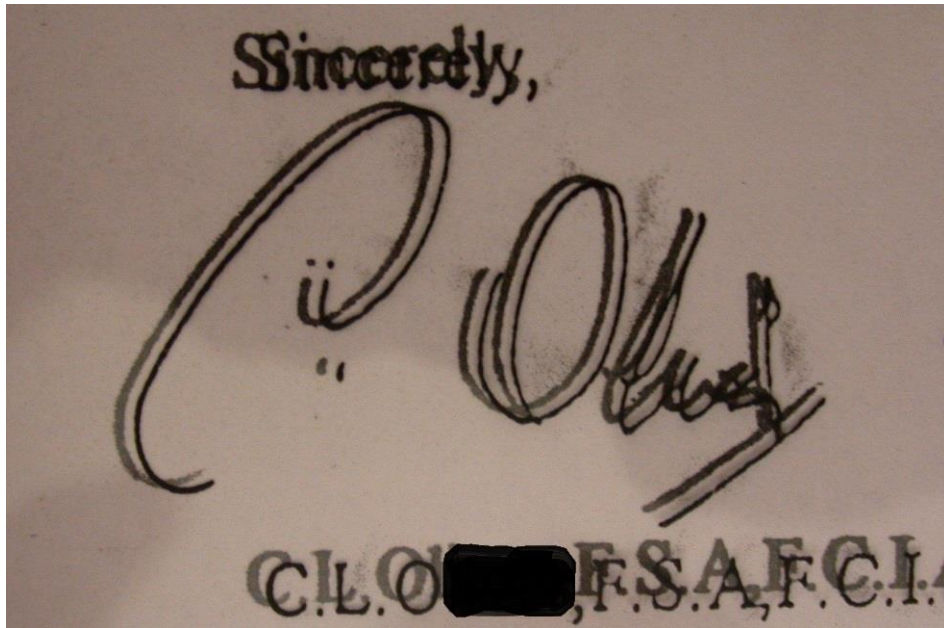

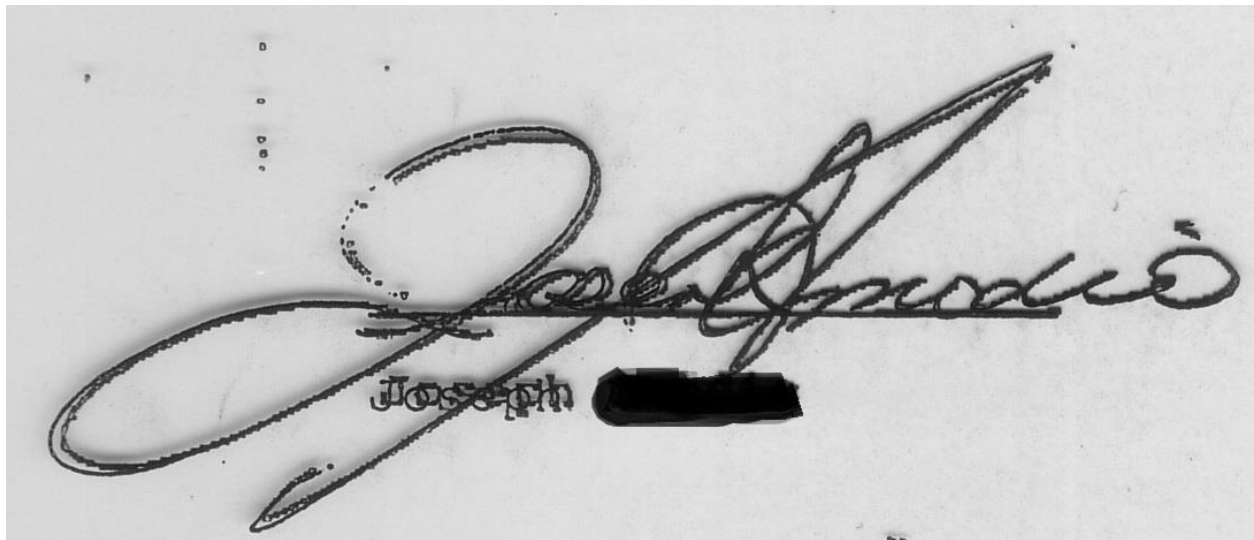
Macro-Image – Over Tracing of Pencil Guidelines




Macro-Image – Over Tracing of Stylus Guidelines



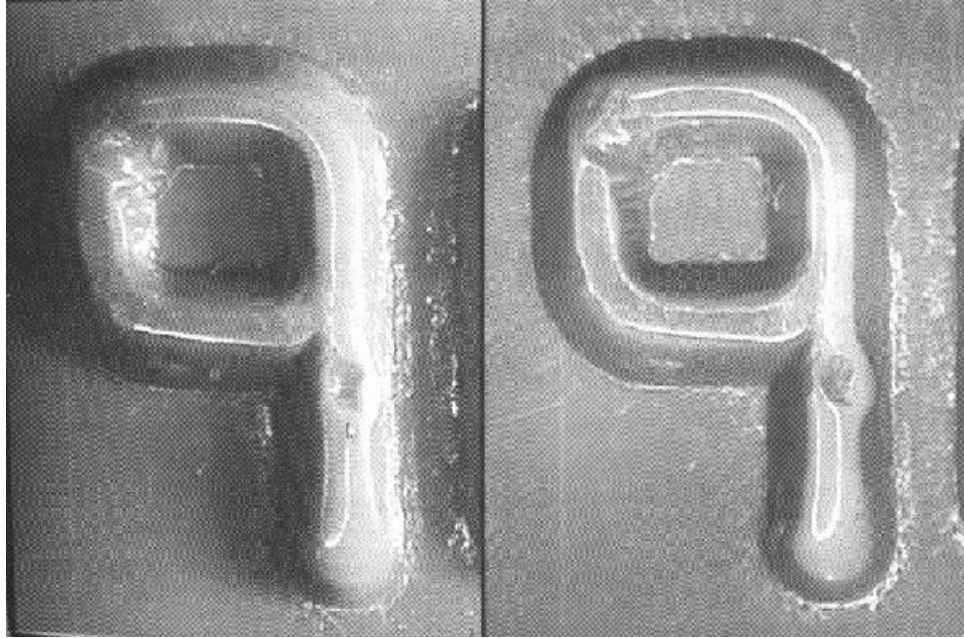

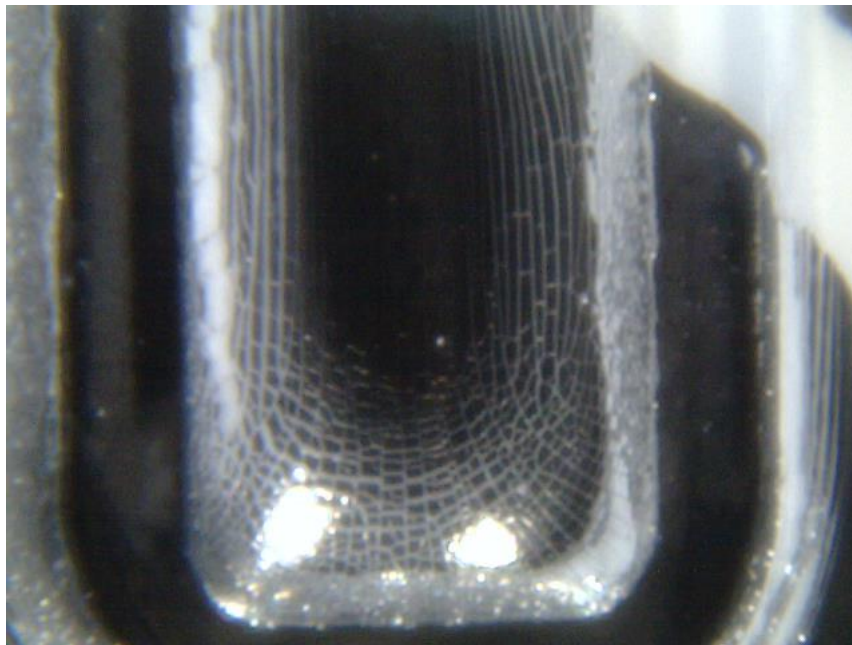

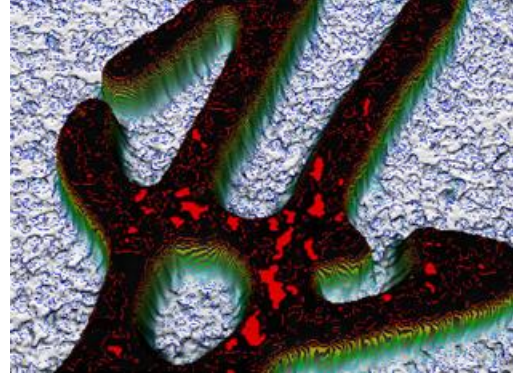
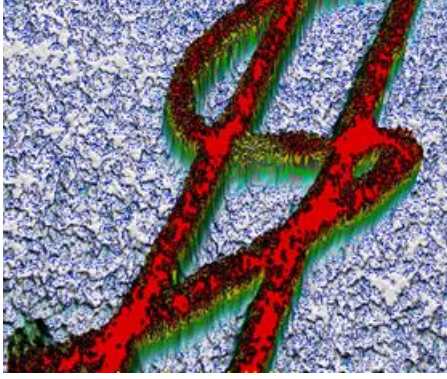

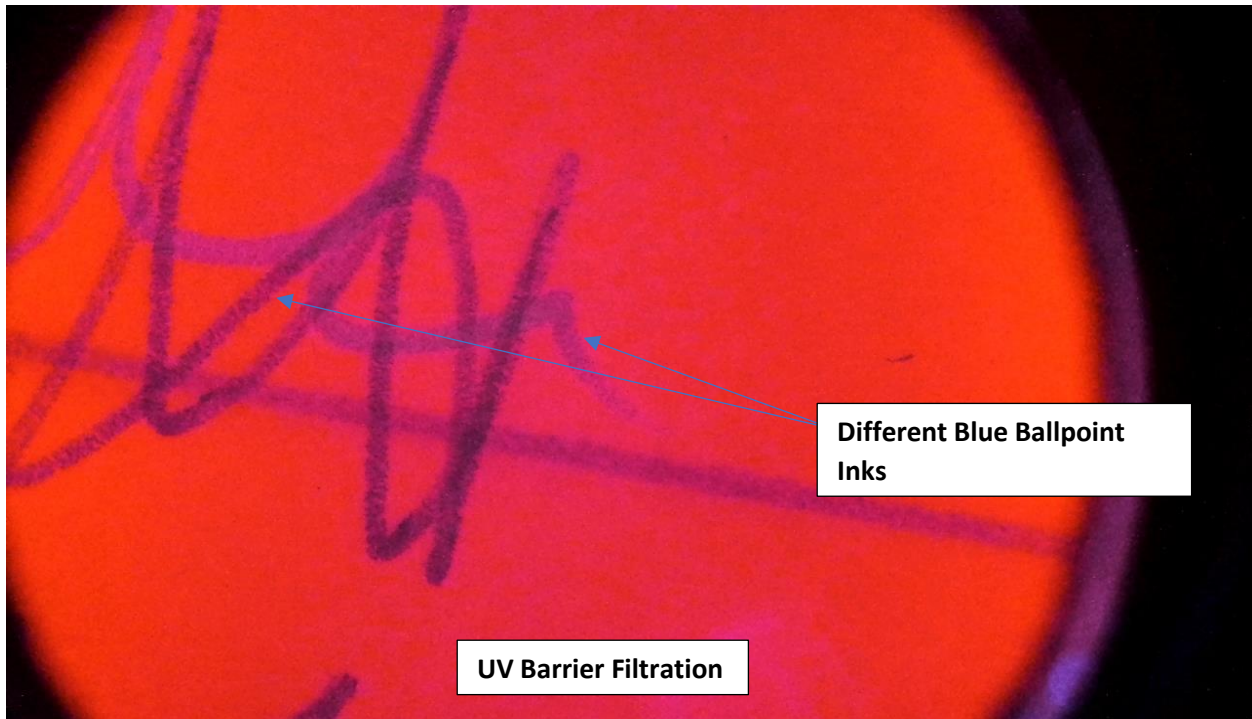
Microscopic view of Embossing Features on a Suspect Visa credit card

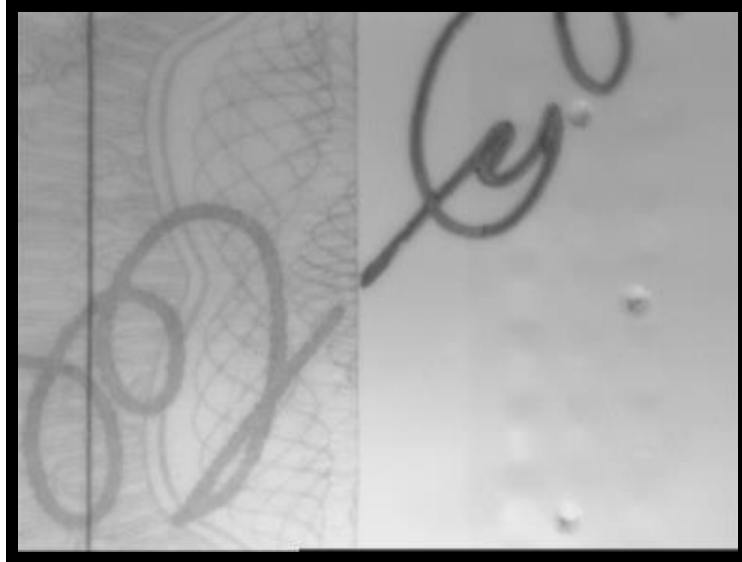

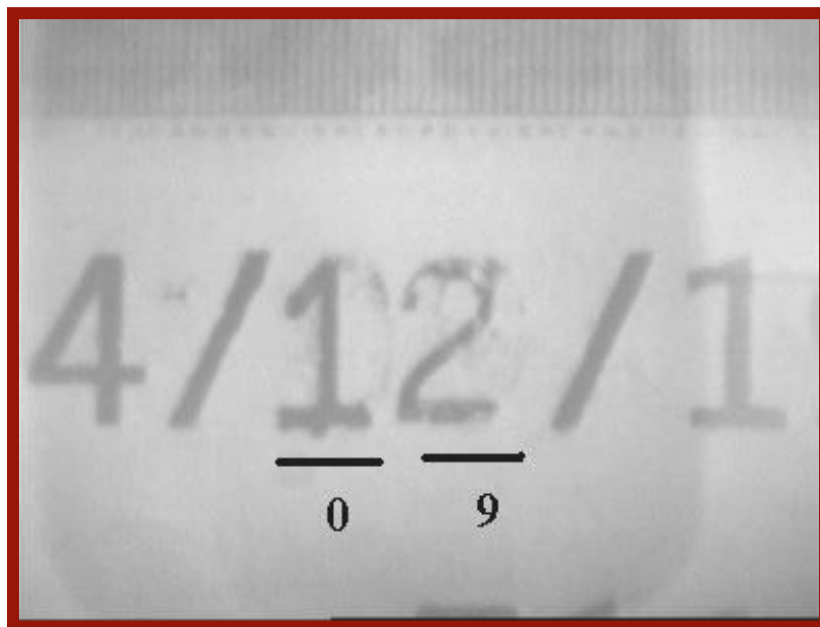

Spectral Analysis for Ink Differentiation

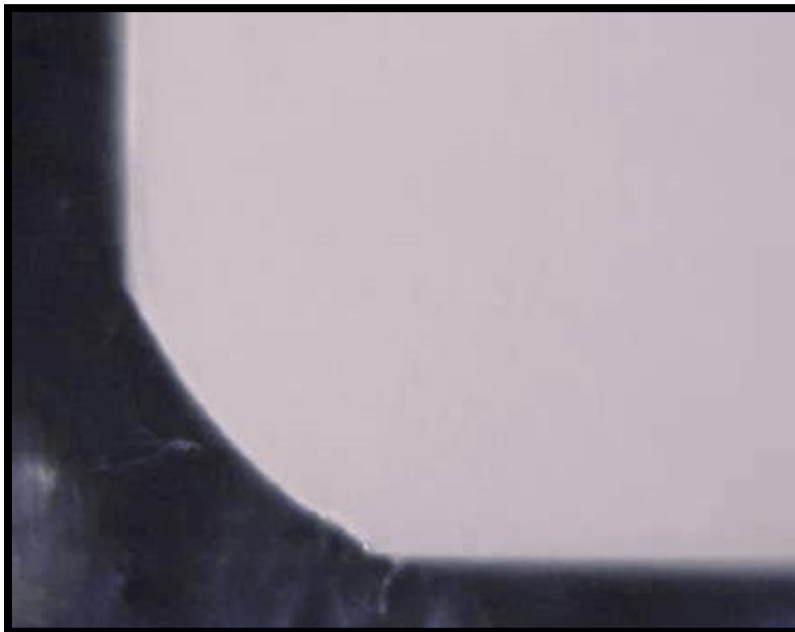
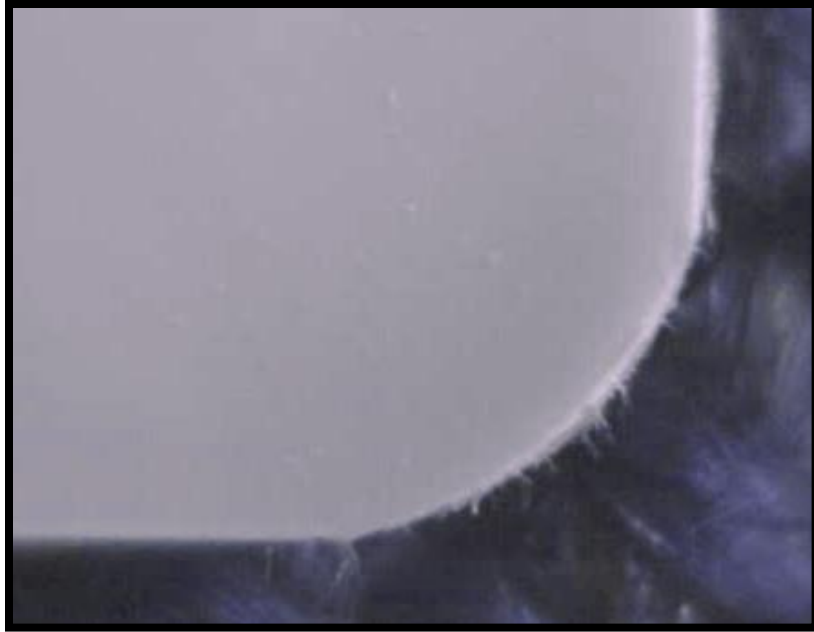


Infrared Filtration identifies the Ink Differentiation of the Signing Authority across the document and the Individual's Photograph

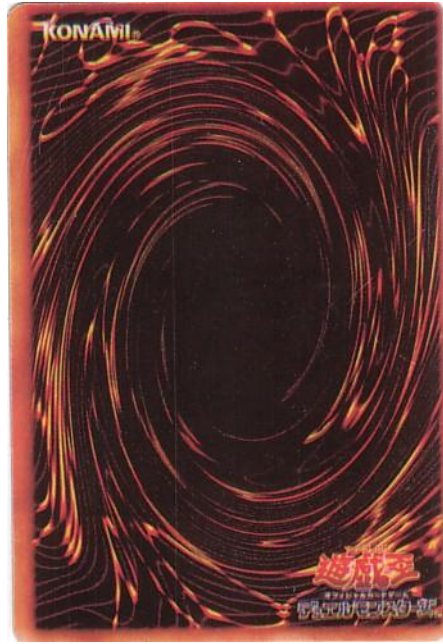

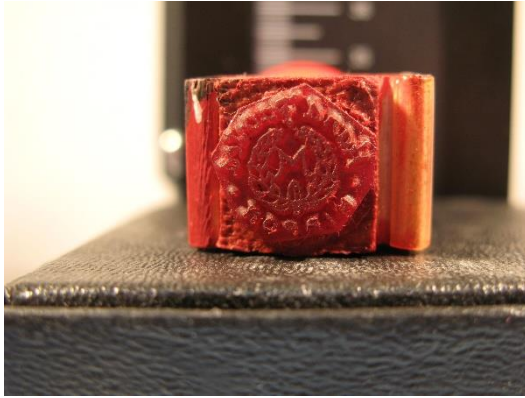

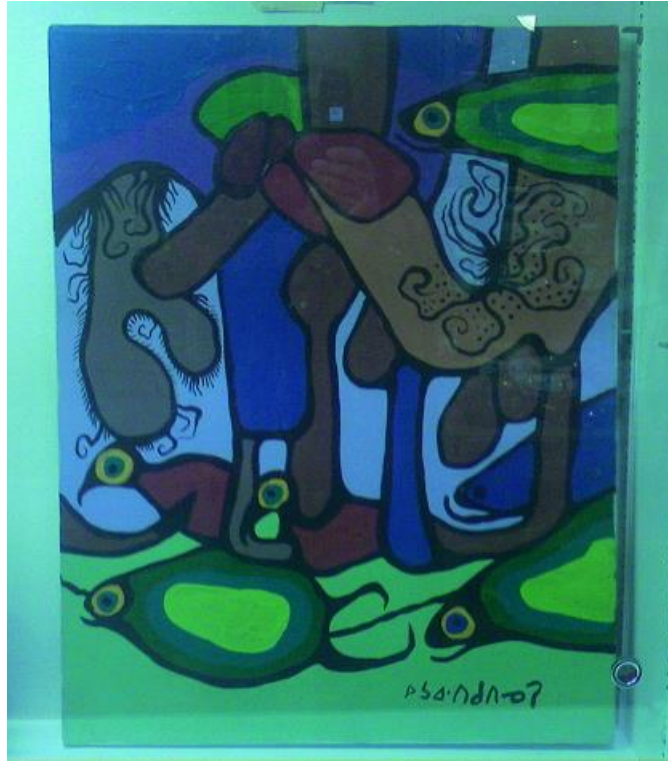
